1. Notes

Stations and panel membership

An optimum level of membership is based on the number of stations visited, the minimum number of visits required of each ICV and the need to build in some resilience for absences. The optimum numbers are 9 members for 1 station, 17 for 2 stations and 26 for 3 stations.

% of visits completed

The London ICV Scheme sets a high benchmark for panel visit performance. The ICV Handbook states that panels may be considered to be performing poorly if they fail to come within their target of scheduled visits by more than 10%. The target is normally one visit per week to every 24/7 custody suite in the borough. Temporary station closures are accounted for. Where panels visit more than once a week by local agreement, and conduct a visit every week, the performance is recorded as 100%. If such panels fail to complete a visit in any week the performance will be recorded as less than 100% regardless of the number of visits conducted in other weeks.

Concerns

Most concerns or issues are minor and are raised and resolved at the time of the visit. The concerns in this table are those which are ongoing, unresolved or have been escalated to the ICV Scheme Manager and CD
