Utilisation of Accommodation

Utilisation of rooms at CLTC is calculated as a percentage figure, based upon operational hours during a Monday to Friday week. However, it is possible to achieve over 100% room usage, as any room usage at weekends is counted additionally.

Following the opening of the CLTC in November 2006, utilisation of rooms has improved substantially; as detailed in the table below.

Detailed Explanation:

Classrooms 2, 3 and 4 are dedicated to custody classrooms. The demand for this course is directly connected to the MPS promotion process for Sergeants, and therefore fluctuations in delivery is expected. In addition this is an 8 day course, so the remaining 2 days the classrooms may have been unused or used by other users. More recently, the 1-day Custody Refresher has become available and this will increase room usage, as it will be delivered in the 'free' days.

Classrooms 5, 6 and 7 are dedicated NSPIS classrooms and usage has increased as the rollout has progressed.

Classrooms 8, 9, 10, 11 and 12 are dedicated PCSO Power Set 3 classrooms. This was a new course that required piloting once the Centre opened and incremental delivery for the first two months to allow trainer development and course adjustments to be made.

Classrooms 13, 14, 15 and 16 have been the most consistently used since the opening of the Centre. This is because the SN courses were already well established and there was no requirement for a pilot or incremental delivery.

Room 17 is for miscellaneous use and caters for the peaks in training demand when additional room space is required.

Since January when the Centre commenced full delivery, the room usage has averaged at 87%.

The conference room usage has not been captured and analysed to date. This is in the process of being completed, but as an estimate it is anticipated that this would be over 85%.
