Headlines from crime statistics

- Total notifiable offences fell by 4.5%
- BCS comparator crime is down 6.4% compared with a 5.5% reduction target
- Burglary dwelling has fallen by 3.5%
- The sanction detection rates for burglary & vehicle crime have fallen due to counting changes required by the Home Office
- Over one thousand fewer robbery offences
- Business crime fell but mainly due to changes in recording practices for fraud & forgery
- Motor vehicle crime has fallen by 12.6%
- Gun crime and Trident gun crime both increased compared with the same three months last year
- Thirteen fewer homicides than the same period last year
- All types of hate crime are down compared with last year

Public Satisfaction Information

Key messages from the surveys

British Crime Survey (Year to 31 December 2006)

• The MPS leads it's Most Similar Force group in confidence in local policing.

Public Attitudes Survey (2006/07 vs. 2005/06)

• Overall confidence and satisfaction in policing remains higher than in 2004/05, but not at the exceptionally high levels seen in 2005/06.

Safer Neighbourhoods Performance Framework (2006/07 vs. 2005/06)

 This shows mixed results: confidence in local policing fell slightly, but feelings of safety during the day remain steady.

Crime Victim Satisfaction Survey (2006/07 vs. 2005/06)

- The overall level of satisfaction with total service remains steady, currently on average at 78% (down from 79% last year, but not significantly so).
- The gap between white and BME victims overall satisfaction with the service has closed slightly, with the gap at 6 percentage points, down from 7.

Anti Social Behaviour Satisfaction Survey (2006/07)

(NB: this is a new survey and so we only have data for 2006/07)

- Aside from ease of contact, victims of anti-social behaviour are less satisfied than those of in the Crime Victim Survey (victims of violence, domestic burglary, motor vehicle crime and of road accidents).
- The gap between white & BME victims is only 1 percentage point.
