**Prepared for the Metropolitan Police Authority Full Authority Meeting
April to January 2005 compared to the same period last year:**

- Total notifiable offences are down overall by 2.3%
- Residential burglary is down 7.9%
- Robbery is falling; down overall by 4.8%
- Motor vehicle crime is falling; down 13.5%
- Gun enabled crime has decreased by 8.2%
- Homicides are down by 12.2%
- Fatalities on the road are falling; down by 20%
- Violent Crime is rising; up by 8.8%

Detections

- The target detection rate for total notifiable offences is being achieved; it now stands at 20.3%. This represents an additional 45,000 detections over the same period last year.
- The sanction detection rate has risen, up from 12.5% to 14.3%, an additional 13,000 sanction detections.

² Robbery includes robbery of personal and business property.

³ Gun enabled crime includes offences against the person (excluding possession of an offensive weapon), sexual offences, robbery and burglary, which have a firearms code, not including theft and handling stolen goods. This includes offences committed with air weapons and imitation firearms.

⁴ Violent crime includes robbery, sex offences and violence against the person.
