

Introduction

This is the February Corporate Performance Report for the 2005/06 Financial Year to date (data to end of December).

What's included? Below each of the seven Policing Plan objectives there is a list of policing plan performance indicators - marked PP. Statutory Performance Indicators – marked SPIs are also included under the relevant Objective. Other indicators (Human Resource and Resources priorities) are grouped at the end.

The information compares the target with the performance during the period year to date (PYTD) and the rolling 12 months where this is available. The rolling 12 months figure balances the PYTD data, as it is not distorted by seasonal factors, which may affect the PYTD figure.

How is performance assessed? A traffic light system denotes the following:

Green - performance is on or above target,

Amber - minor variation from the target (within 10%),

Red - variation from target is greater than 10 percent.

What happens if a traffic light glows red? If a performance assessment is shown red, a short note explaining the reasons why will be included. Where MPA and MPS officers agree that there is a real problem (i.e. not a seasonal increase), further information will be provided showing the trend over time, and to assess whether remedial action is needed to hit the target. If PPRC feel that the problem is serious enough, then we can produce a more detailed report for a future meeting that will contain further analysis and proposed actions.

New for 2005/06: Home Office iQuanta rankings are now included where relevant. In this, the Metropolitan Police is compared against its Most Similar Forces (MSF) and it's rank (1 – best; 5 – worst) shown. In addition, the electronic version of this document now includes links from the traffic light summary page to the relevant piece of the document.

Performance Summary: Year to Date December 2005

With data for nine months of the financial year, the MPS is currently achieving 31 of its targets (green lights), while 11 are currently within 10% (amber) and another 11 are off target (red). Since the last PPRC report, six indicators have improved from amber to green, notably amongst the violence objective (Objective 7). One indicator moved from green to amber (police staff sickness).

The success of Operation Halifax (an operation to target those suspects who have outstanding warrants) is clear - both traffic lights are now green, and the number of outstanding warrants held by the Metropolitan Police is down 25%.

Safer Neighbourhoods continues to show results in reducing crime: in the financial year to December, all crime is down 2.6% in Safer Neighbourhoods areas, compared with a 1.8% reduction in Non Safer Neighbourhoods areas. Key reductions include criminal damage (down 10% in SN areas), violence (no change in SN areas compared with 3% increase in Non-SN areas) and vehicle crime (down in SN areas, up in Non SN areas). However, the increase in robbery is greater in SN areas.






Some areas of concern remain: it is unlikely the MPS will achieve its targets for robbery, violence, vehicle crime and burglary reduction. In addition, many of the violence sanction detection indicators remain some distance from their targets. It should be stressed that the size of the increase in robbery, gun crime and violence has diminished over the last few months.

There are early indicators that the MPS is beginning to improve performance against those in the Most Similar Force group: the MPS has the 2nd best burglary SD rate, and has moved from the bottom of the 'riskiest' areas indicator for both household and personal crime (see Objective 4) to 4th - (year to June 2005). It is also 3rd best for reducing BCS comparator crime.

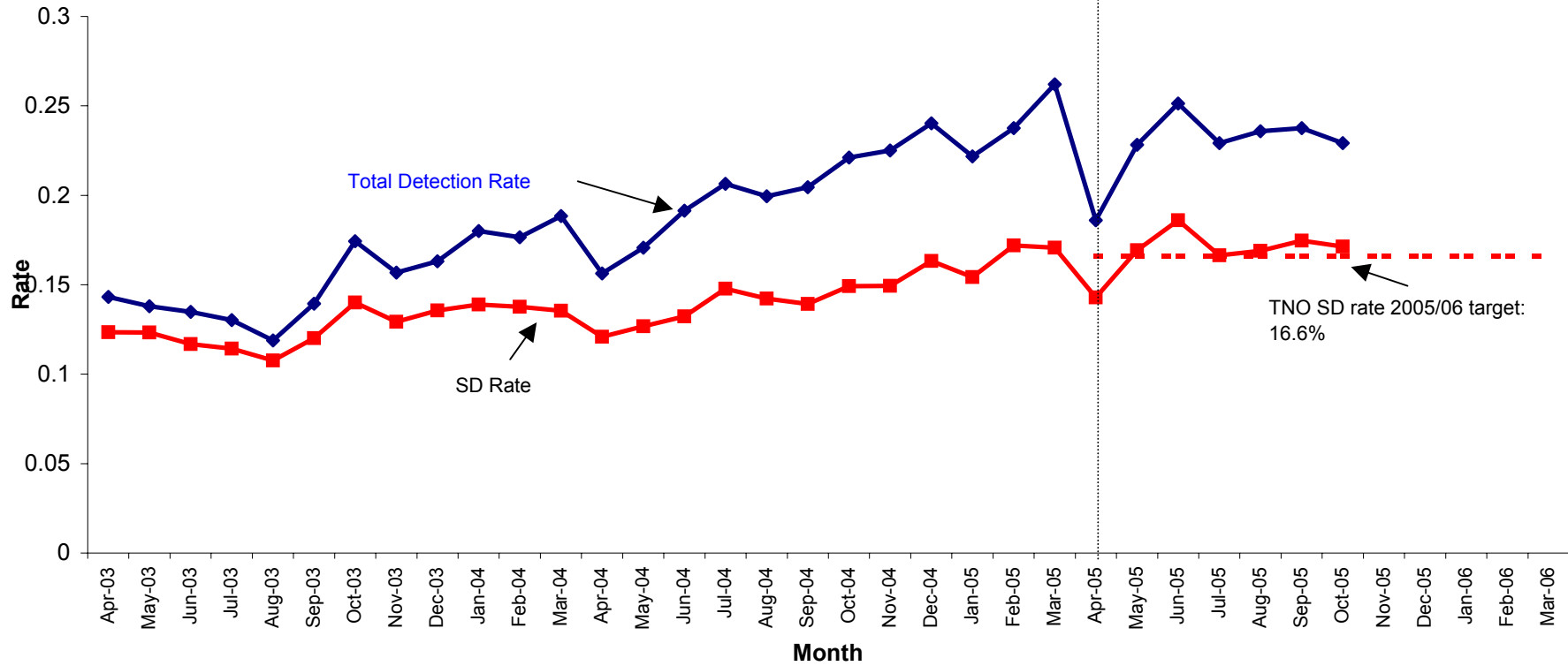


◆ Robbery Offences

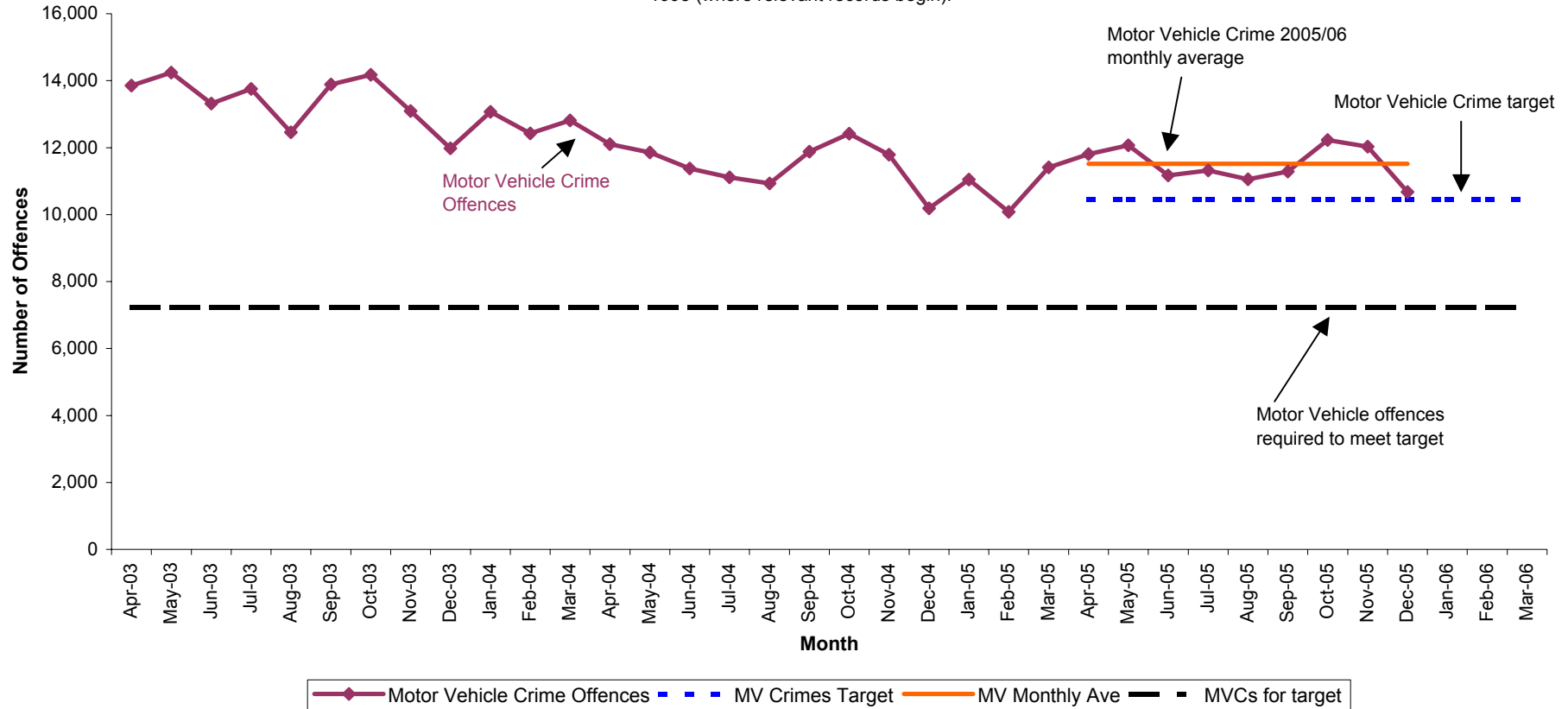

Motor Vehicle Crime: Performance since April 2003

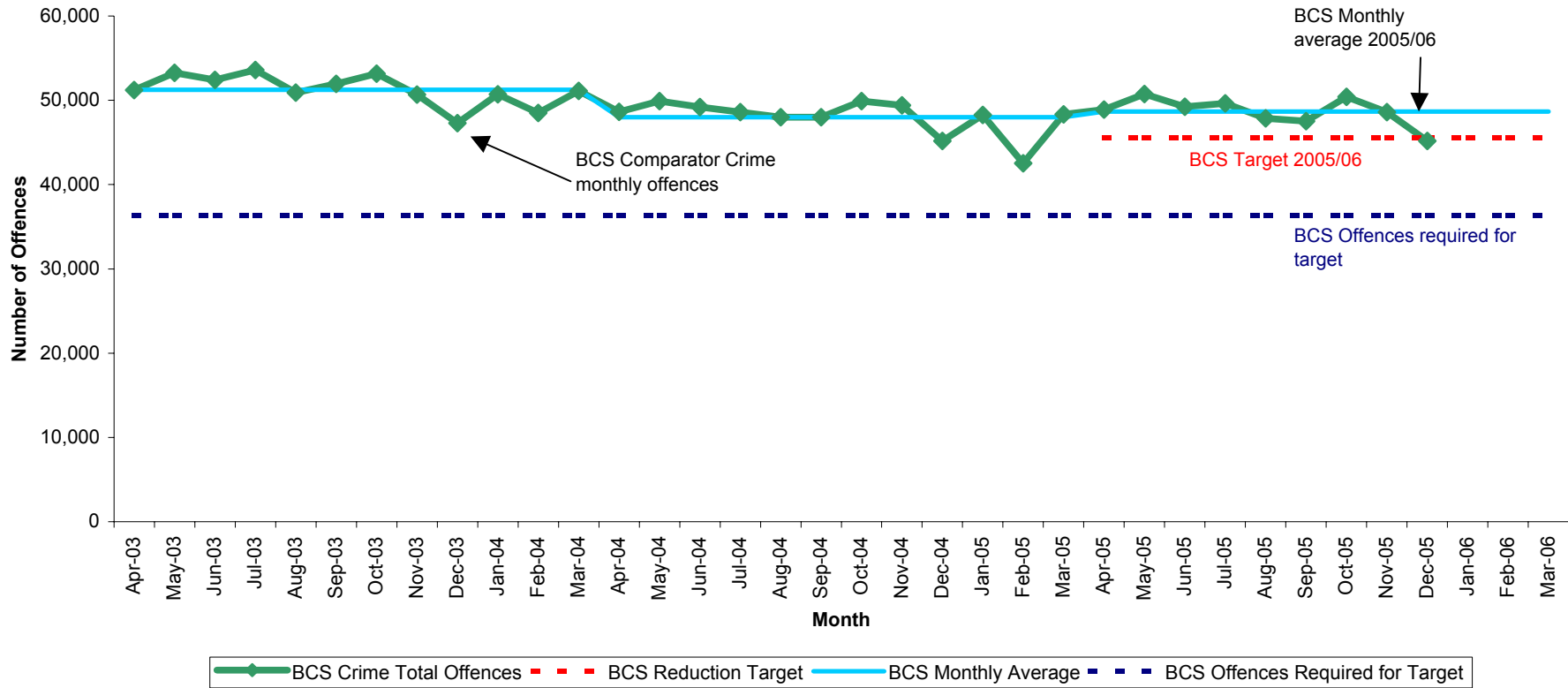

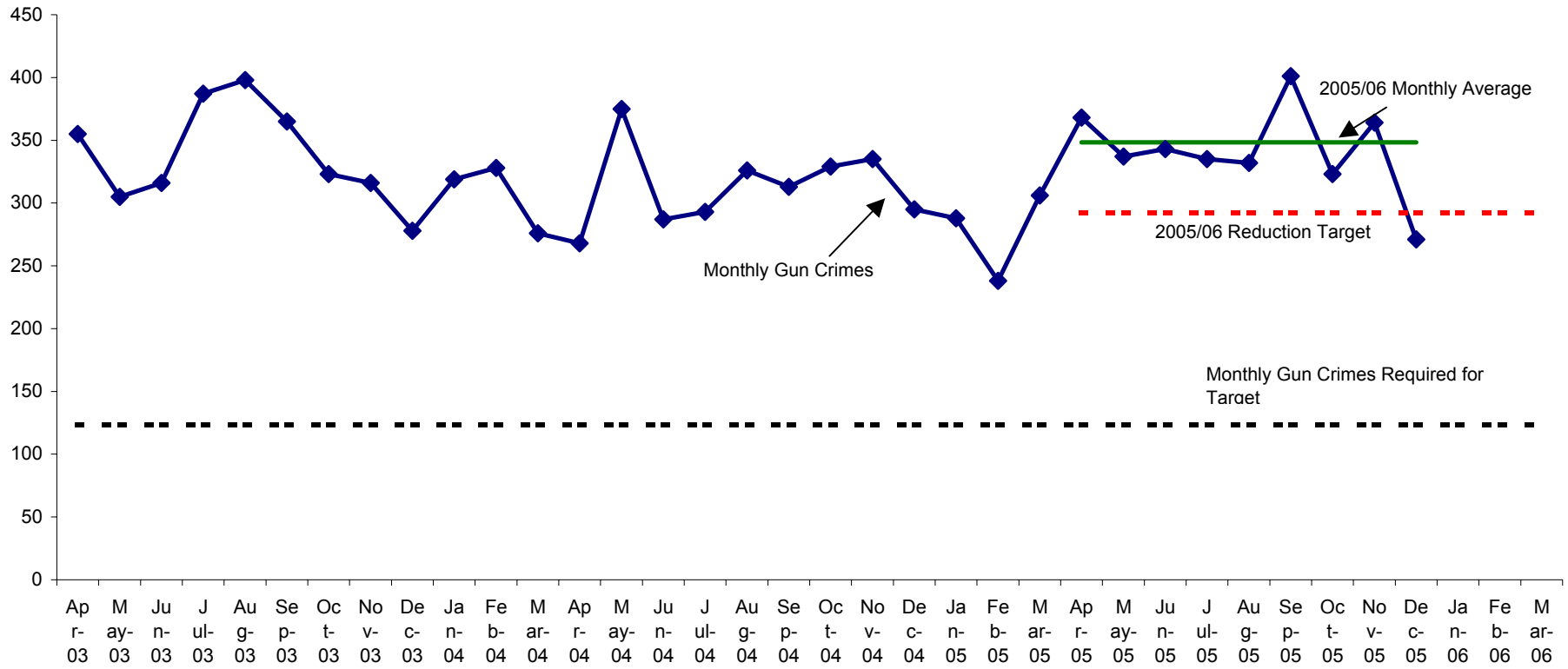

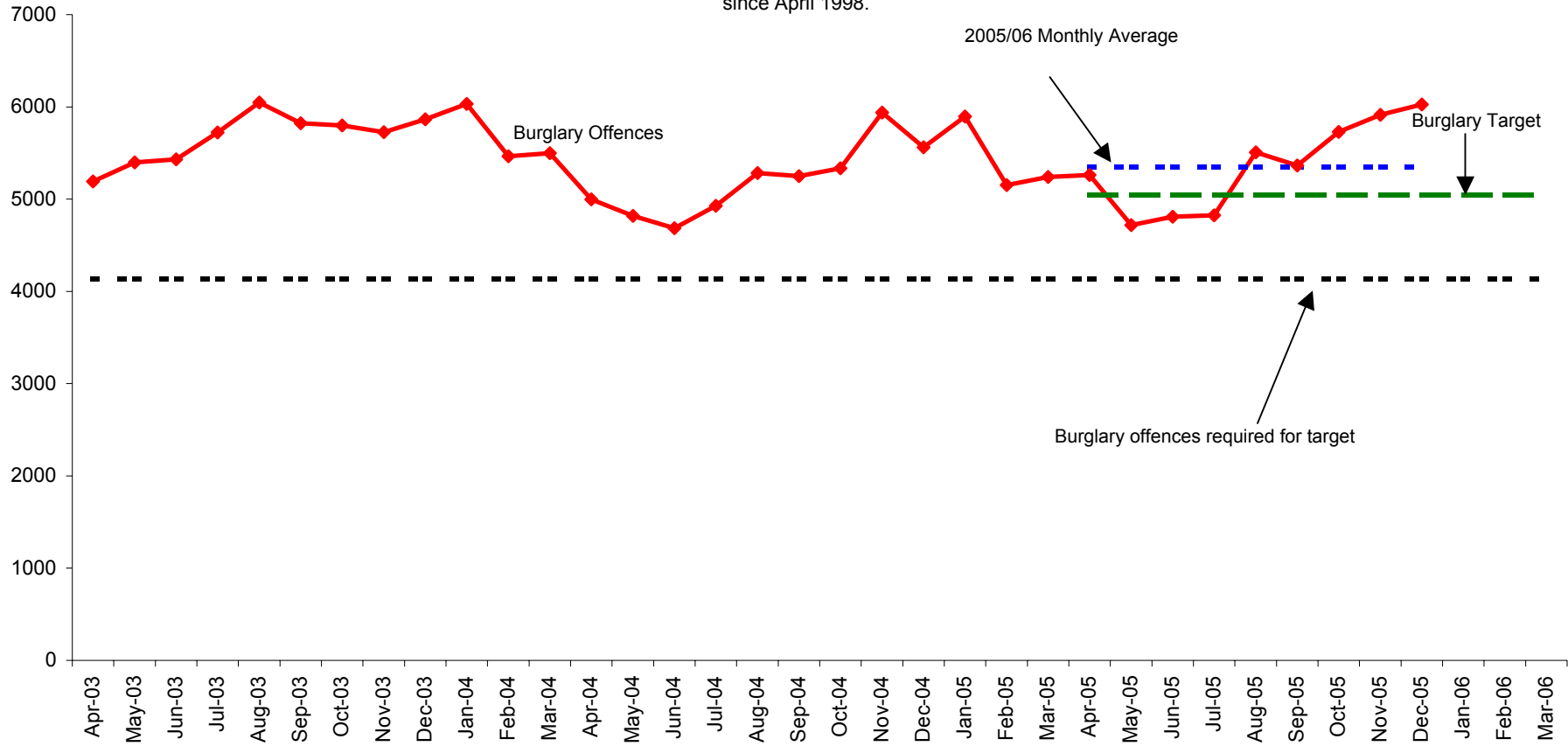

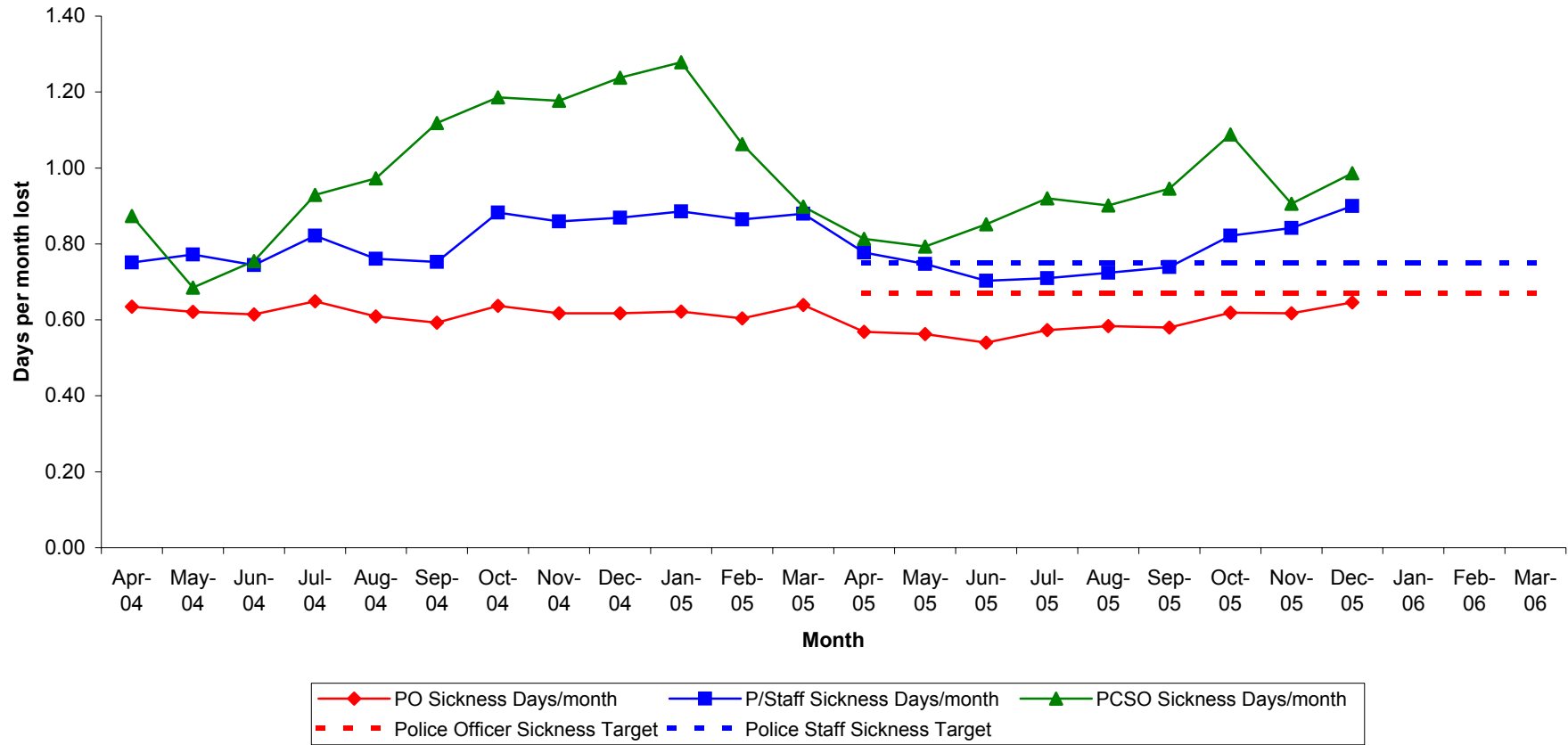

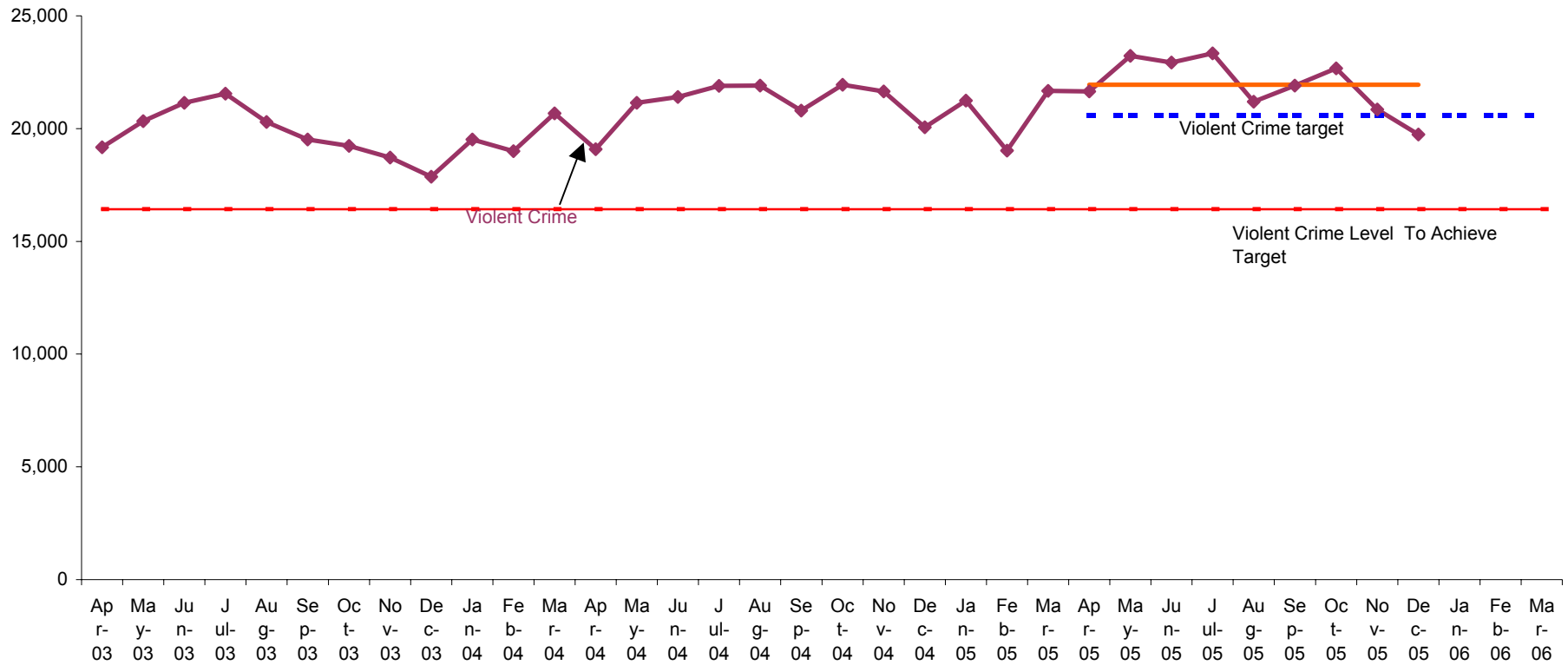
