

NE Region – Public Complaints

Barking & Dagenham, Enfield, Hackney, Newham, Redbridge, Tower Hamlets, Waltham Forest

Top 3 BOCUs

Tower Hamlets

Tower Hamlets has the highest allegation rate per 100 officers. There were 332 officer allegations against officers in Tower Hamlets recorded in the year June 2004 to May 2005. Of those allegations, 19% were for other assault, 18.7% for failures of duty and 17.2% incivility.

Tower Hamlets recorded the highest number of discriminatory behaviour allegations (28) within the NE region. There were 27 allegations for race and 1 for homophobic behaviour.

Enfield

Enfield recorded the second highest number of allegations per 100 officers within the NE region. The actual number of allegations is 3rd highest, with Hackney recording 278 allegations against the 226 recorded in Enfield. 26.5% of allegations recorded were for other assault, with 26.1% failures of duty, 15% incivility and 10.5% oppressive conduct or harassment. 3.5% of officer allegations were recorded for discriminatory behaviour, equating to 8 allegations of racist behaviour. Enfield has recorded the 3rd lowest number of allegations in this category within the NE region.

Havering

Havering recorded the third highest number of allegations per 100 officers for the rolling year June 2004 to May 2005. The actual number of allegations recorded was 141 with nearly 40% of those allegations for failures in duty. The next highest proportion of allegations was recorded for other assaults (23.4%) and 17% of allegations for incivility. Only 1.4%, or 2 allegations were recorded for discriminatory behaviour. These were both against race.

Hackney recorded 278 officer allegations, Waltham Forest 183, Newham 210, Redbridge 123 and Barking & Dagenham 96.

Hackney recorded 20 officer allegations for discriminatory behaviour, with only Tower Hamlets recording more (27). Redbridge recorded 15 allegations of race and Waltham Forest 10 for race and 1 for disability.
