I've had considerable discussion recently with PSD colleagues around disposal options for Hampstead. As you may know, we thought there was a possibility of some space at the Post Office which is due to be sold. Unfortunately, although we have tried all possible approaches, the PO is committed to another partner already and it now appears that this is a dead duck. At the same time, there is virtually nothing else on the market in central Hampstead which would be suitable to accommodate your residual functions such as SN, Front Office, CPO etc. and even if there was, the cost would probably be prohibitive.

We have been discussing some options for a joint venture on a sale and development of the existing site which might include an ongoing presence for the above functions in the same location. In order for us to be better advised regarding these options we will be seeking professional input from a consultant (Atkins).

It may very well be that Atkins personnel will need to visit Hampstead PS to look around and I'd be grateful if you could facilitate these visits without necessarily raising too much alert amongst staff.

In the meantime, as I noted again from my visit this week, there is considerable unused space at Hampstead and it would be good to ensure that this does not become occupied, so that options for disposal remain uncomplicated.

All Borough SMTs are being invited to ESB from the 15th - 18th November inclusive to discuss the 2006 Rollout of Safer Neighbourhoods, including accommodation. I hope to see you there or have a property representative available to discuss accommodation.

My aim is to arrive at an agreed accommodation plan at the meeting. This will include 1. The size of the Bases (the number of Teams sharing the Base).

- 2. The location the Bases (identified clearly on roads between junctions if possible).
- 3. Where you want Safer Neighbourhood Contact Points at Bases to give a Borough-wide spread.

A fundamental basis for the plan is for more Teams to share the Bases. As a guide, a minimum of 2 teams on average, should share each Base. In inner Boroughs , with geographically smaller wards, a greater degree of sharing may be possible.

The increased sharing is an unfortunate necessity arising from Budget cuts. Wherever possible future Bases should be located close to Ward boundaries permitting each Team to reach their Ward reasonably easily.

Other Asset Plans from Property Services involve the closure and disposal of old outdated and expensive properties in due course which can be replaced with new Safer Neighbourhood bases with contact points for the public. The following premises below may well fall into this category and we have to plan accordingly.

To the Editor of the Ham and High,

I would like to respond to several of your, articles focusing on Policing in Camden.

As your reporter is well aware, although he didn't indicate it, there are currently no plans to close Hampstead Police [Join our campaign to save police station - P.1 7/10/05].

Hampstead is one of 174 police stations and 600 operational buildings across London that forms the MPS estate, an estate that is constantly under review.

The MPS has an Estate Strategy focused on making its buildings more appropriate for the demands of policing in the 21st century. This can involve modernising and refurbishing properties or disposing of buildings not suitable for modern day policing, and reinvesting those savings to deliver more appropriate facilities. A review of Hampstead's facilities has been conducted and its findings will contribute as what its future use may be.

One of the difficulties faced by Hampstead Police Station is that as a listed building we are limited in what we can do to improve the facilities it offers to the people of Hampstead who use it. Currently the borough is refurbishing West Hampstead front counter, with Kentish Town to follow so that we have environments, similar to Holborn, that provide an effective service to the public.

In addition to this, whilst the outside of Hampstead Police station looks nice and is rightly a listed building, the inside is currently unfit for modern policing. What are needed for today's service are buildings that are in a good location, are well facilitated, have modern and practical cell complexes and are able to incorporate up-to-date technology. A review of the

facilities that Hampstead will establish if this can be achieved through refurbishment.

Your reporter, however, is correct that I do feel there is a clear need for a Police presence in Hampstead High Street, and this is why Hampstead Police station will not shut until there is a viable replacement for it. It is MPS policy never to close a police station with front counter facilities without first opening a replacement.

As an organisation, and as a borough, the focus is now on neighbourhood policing, and this brings with it a need for a more visible and effective local presence. We need to provide Safer Neighbourhoods teams with suitable 'shop-front' space that are then supported by well facilitated and better located, police stations that together can provide a better service to the public.

In response to Ed Fordham (P.1 7/10/05), the purpose of moving towards Safer Neighbourhoods teams is to develop local knowledge, develop local relationships and deal with local issues as directed by local people, through Citizen Community Panels. This is only enhanced by basing them in the local community, not in an office in a secure police station, that can't allow the public access to them as highlighted in another article [Its almost impossible to get hold of police now P.4 7/10/05].

In the financial year to date, crime in Camden is down by 8%, the previous financial year is was down 12%. I want this to continue and to do that Camden Police will need to change and grow as it continues to move into the 21<sup>st</sup> Century. This reduction in the number of crimes in Hampstead is a reflection of this and the good work put in by all the officers on Camden Borough.

In a majority of wards that have their own Safer Neighbourhoods Team, crime has fallen further and I hope this continues as we try to role out Safer Neighbourhoods Teams to all wards across the borough ahead of schedule. The MPS now wants to advance the role out of Safer Neighbourhoods Teams to all wards across London by the end of 2006 and not wait until 2008.

As with the expansion of any organisation, the budget for the work force available to us has to be adhered to. The possible dissolving of the current format of large Sector Teams and the introduction of brand new Safer Neighbourhoods teams, that are smaller and more bespoke, does not mean a reduction in police in Hampstead, Camden or the MPS. What it does mean is that, as a Borough, and as an organisation, we are trying to worker smart as well as working harder to improve the communities we serve.

With Safer Neighbourhoods teams, communities can be guaranteed that a minimum amount of officers will always be working in their area to tackle the issues that are most concerning to them. It would be easy to ask communities to dip further in there pockets to fund the police force they want, but this is not what is wanted by anyone, police or tax payers. Instead what we all want is effective policing that works and that Safer Neighbourhoods isn't a drain on

#### resources.

The continued recruitment by the MPS, and its ongoing work with its partners such as the Home Office and the GLA in organising funding helps us expand to produce Safer Neighbourhoods teams. But recruitment takes time, and if there are officers undertaking roles that overlap with the ethos Safer Neighbourhoods then it is only right that we utilise the skills of that officer within the Safer Neighbourhoods structure, rather than recruit to duplicate that work.

In essence, the MPS will continue to grow, employing new people, replacing those that move on or who are promoted, as has always been promised. What has changed is that instead of waiting to fill the Safer Neighbourhoods teams, we will fill them from the resources we have available recruit to replace and assess whether the recruit can be used in a more effective way than was done previously.

This is the thinking behind the alteration to sector teams. No community will lose out on the number of officers it has available to it. Instead it will gain from and increased visible presence (Safer Neighbourhoods teams) and the greater backing of expanded response teams to answer emergency 999 calls, and expanded dedicated units for investigating priority crimes.

I feel sure that communities are more reassured by a visible number of dedicated officers that are not going to be removed, backed up by a streamlined and fluid support team that can be there when needed, instead of the thought that there may or may not be 60 officers in station that they may or may not see and that may or may not be working in the sector they are based in.

It is pleasing to know though that the discussion of these issues has arisen from a public meeting. This is the purpose of my officers and I attending such meetings. We will continue to do so to inform and explain how the service is working and developing, as well as listening to and consulting with the people we serve.

24/7 response base agreed with the location to be within 1 - 1.5 KM radius of Camden Town Tube Station.

Separation of House from Hampstead Police Station to accommodate Front Office, CPO, and 2 Safer Neighbourhood wards subject to structural requirements. and parking facilities being available.

If a suitable 24/7 base cannot be sourced as per our requirement, development of existing Kentish Town Police Station and Section Hse to be considered.

Please let me know whenever a potential 24/7 site is identified so the Command Team can assess its suitability. Regards

**Subject:** Hampstead PS disposal

Colleagues

I include below a few notes from our meeting last Friday.

<u>General discussion</u> centered on a viable accommodation strategy for Camden BOCU. It was agreed that the disposal of Hampstead PS was to some extent dependent upon the provision of a 24/7 Response base for the BOCU and a clear strategy for the future of Kentish Town PS. There is

also the question of the future disposition of custody for the borough but it was agreed that this could be treated as a separate project and would not hinder the provision of a 24/7 RB or the disposal of Hampstead.

It was agreed that the disposal of Hampstead should provide an adequate funding stream for 24/7 and other possible accommodation initiatives.

.pecific discussion regarding the disposal of Hampstead PS achieved agreement that essential functions to be preserved in the Hampstead community are: 2 Safer Neighbourhood Teams, a Front Office and the CPO - a headcount not exceeding 15 staff. Julian Swaysland presented drawings of the site to show that these functions could be adequately accommodated if the house adjacent to the PS was to be retained from the disposal and remodelled to provide suitable accommodation.

It was further agreed that, in respect of other functions currently accommodated at Hampstead PS: Sector Team - is the subject of impending tactical discussion by BOCU, but role may change in relationship to neighbourhood policing Safer Schools Team - BOCU to review optimum location but agreed that this does not have to be at Hampstead Street Duties - agreed that in the long term this will be subsumed into IPLDP and will be accommodated elsewhere (possibly atArchway) BSU, Crime Squad and SOCOs - agreed that these will move either to Kentish Town or (ideally) to the new 24/7 RB.

It was agreed that John/Arthur will re-write their business case to address not only the issue of Hampstead PS but also the wider BOCU strategy including future options for Kentish Town PS & Section House, and options/possible locations for 24/7 RB.

Agreed that PS will action a specific search once this business case is received and agreed. Agreed that, in the meantime Julian will continue to assess disposal feasibility/options through Atkins.

The estate strategy published by the Metropolitan Police Authroity (MPA) [please see <a href="http://www.mpa.gov.uk/downloads/issues/estate/buildings.pdf?">http://www.mpa.gov.uk/downloads/issues/estate/buildings.pdf?</a>] makes clear the need to replace older buildings with newer fit for purpose options that can be operated within available property budgets. The MPA and Metropolitan Police Service (MPS) have committed that no public front desk will close until an alternative provision is available. This renewal programme, along with additional Safer Neighbourhood bases (and "contact points"), will see no loss of front desk service but an overall increase in places the public can interface with the Service.

No master list of works exists and work is ongoing to prepare plans that can be discussed, borough by borough, via partnership arrangements and can be changed within available funding levels. These Borough discussions will be led by the relevant Borough Commander.

Replacement locations will, wherever possible and practicable, be nearby to the old non fit for purpose "stations" but where the existing stations are no longer in a location where people and communities can easily access them a wider repositioning may take place. This is considered on a site by site basis.

The MPS employs a number of external consultants in many specialist areas. Over the course of our ownership of Hampstead Police Station many different property consultants will have been utilised at one time or another. The following are currently "active" on this project:

WS Atkins are planning consultants and were appointed in August 2005. Their remit was to provide a report on the planning status of the site. This would cover such areas as redevelopment, potential change of use and the listing status;

SMPA are Chartered Surveyors and were appointed in Nov. 2005. Their remit was to conduct a survey of available alternative sites which would satisfy the projected policing requirements of Camden Borough for the Hampstead area.

Property Services staff have been continuously involved in estate matters related to Hampstead Police Station (and all other MPA property) and have worked closely with external consultants.

In accordance with the current MPA estate strategy (see link above) the viability of

older police stations is under constant review and accommodation on Camden BOCU is dealt with in liaison with the Borough Commander.

Local community liaison meetings are held by the Borough Commander or his senior management team and, when estate matters are on the agenda, it is usual for a Property Services representative to be invited along: Property Services last attended a meeting on 25th October 2005.
