## Nationwide Roll Out of Criminal Defence Service Direct Call Centre

With effect from 21 April 2008, the way in which arrangements for detainees to access legal advice and/or a solicitor changes. This will not alter the way the police work merely the way services are allocated.

These reforms relate to the arrangements for providing publicly funded legal advice at police stations, and in straight forward matters this will now done the be via Criminal Defence Service (CDS) Direct CDS is an scheme. essential support mechanism the to success of the wider reforms to legal aid, that flow from Lord Carter's independent review of legal aid

procurement.

The contents of Notes for Guidance 6B of PACE Code C will be superseded by 6B2 in all police forces areas in England and Wales.

6B2: A detainee who asks for legal advice to be paid for by himself should be given an opportunity to consult a specific solicitor or another solicitor from that solicitor's firm. If this solicitor is unavailable by these means, they may choose иÞ to two alternatives. lf these attempts are unsuccessful, the custody officer has discretion to allow further attempts until a solicitor has been contacted and agrees to provide legal advice. Otherwise, publicly funded legal advice shall in the first instance be accessed by telephoning a call centre authorised by the Legal Services Commission (LSC) to deal with calls from the police station. The Defence Solicitor Call centre will determine whether legal advice should be limited to telephone advice or

whether a solicitor should attend. Legal advice will be by telephone if a detainee is:

\*detained for a nonimprisonable offence,

\*arrested on a bench warrant for failing to appear and being held for production before the court (except where the solicitor has clear documentary evidence \*available that would result in the client being released from custody),

\*arrested on suspicion of driving with excess alcohol (failure to provide a specimen,

\*driving whilst unfit/drunk in charge of a motor vehicle), or

\*detained in relation to breach of police or court bail conditions.

An attendance by a solicitor for an offence suitable for telephone advice will depend on w h e t h e r l i m i t e d exceptions apply, such as: \*whether the police are going to carry out an i n t e r v i e w o r a n identification parade,

\*whether the detainee is

eligible for assistance from an appropriate adult,

\*whether the detainee is unable to communicate over the telephone,

\*whether the detainee alleges serious maltreatment by the police.

Apart from carrying out these duties, an officer must not advise the suspect about any particular firm of solicitors.

## Update on Pilot Project to Promote Independent Monitoring in Chinese Police Detention Centres

Last year we told you about a delegation from China who had visited the MPA to discuss the London ICV scheme, in the hope that a similar scheme could be piloted in China.

Orlando Edwards from the Great Britain China Centre (GBCC) has sent us the following update on the pilot's progress, he writes; 'The 6 month project is taking place in Liaoyuan, a town near to Shenyang, Jilin Province in Manchuria (north east China). which has recently seen more than its fair share of torture cases. Before the pilot begins, our Chinese the Peoples partners, University of China, will send Beijing researchers to look into the current situation regarding complaints, interrogation facilities, detention facilities (including both short

term police cells and centres) detention and current practice to provide a pre-project benchmark of practices. This will be followed by the selection of 10-15 visitors from Liaoyuan People's Congress and the People's (Lay) Supervisors. They will be normal, working people and will need to be paid in order to make the visits. Chinese partners have asked for advice on the process, selection and appointment o f Independent Custody Visitors in England and details have been provided (by the MPA).

At the end of this month, GBCC and The Rights Practice will travel to north east China to deliver training workshop for the Chinese lay visitors. The training will be similar to the training that ICV's in the UΚ receive. emphasising that the training is from the perspective of an Independent Custody Visitor in London; roleplay exercises and what to expect from a typical visit, reporting and monitoring. For one exercise, we plan to act out a little role-play and perform it in Chinese! After the training, monitoring visits will take place over a two month period and the People's China University of researchers will make frequent visits to the detention centre to see practices have how changed and what difference the visits make. The whole idea of independent visits is very new to China. The researchers will therefore write up their findings in a report at the end of the project which will be discussed with decision makers and leading influential officials from the Supreme People's Procuratorate. the

Ministry of Justice and the Supreme People's Court as well as influential academics and of members the Legislative Affairs Commission in Beijing in June with the aim of promoting this initiative more widely throughout China.

The overall aim of this pilot project is to demonstrate a workable mechanism to enable China to ratify the Optional Protocol to the UN Convention Against China. The project has received some funding from the a n d Foreign Commonwealth Office and some funding from the European Institute Democracy for and Human Rights, but is still looking for some funds to cover the costs of the evaluation and recommendations seminar.'

This is not the case, ICVs usually speak with custody staff to establish if detainees will be available to see ICVs, but it is not compulsory. We apologise for any confusion.
