Meetings with MPS Custody Directorate

At the ICV Conference we promised to use this newsletter to provide feedback on the regular meetings between the MPA and the MPS Custody Directorate (CD)*. Custody issues and queries regarding procedure, process and policy can be brought to the attention of ICV Scheme Manager, Kerry McClelland, through your Coordinator.

Some of the issues addressed at recent meetings are included below.

MPA: ICVs have asked whether hand wipes or gel could be routinely offered to detainees before they eat. **CD:** Will investigate alcohol-

free products that could be used.

MPA: ICVs raised an issue that there were no Halal meals available and that custody staff did not always appear to see this important. CD: as Clarified that there should always be Halal and Kosher meals on offer and will send an email reminding staff to keep stocks up.

MPA: Update on body dryers. **CD:** Investigated the environmental impact of body dryers vs. use of towels (laundering etc). Body dryers have quite a high impact and can also increase the spread of germs. MPS Property Service Department is therefore currently looking in to a prototype towel which would be suitable for use in custody.

MPA: ICVs frequently raise issues about the FME room door and drugs cupboard being left open. **CD:** Confirmed that both the FME room door and the drugs cupboard should be locked at all times when not in use, and will be working on the Standard Operating Procedure to reflect this specifically. CD is in the process of replacing drugs cabinets in FME rooms with proper drugs safes, which will eradicate the issue of these being left open. When nurses are introduced in to custody suites there will also be a

protocol in place regarding pharmaceutical supplies and up to 12 prescribed drugs that can be dispensed by nurses. More information will be provided as received.

MPA: ICVs are concerned that with the changes to police officer training, many new recruits do not appear to have heard of ICVs. **CD:** Will look at feasibility of incorporating something on the role of ICVs in the e-learning package for officers.

ICV Handbook review

The ICV Handbook was first distributed in April 2007 and it was envisaged that it would be reviewed after a period of usage. We will be starting a review in September 2008 and all ICVs will have the opportunity to contribute either individually or through their panel. A review form will be created and circulated, enabling us to capture suggestions in a structured way. The review period will last several months, in order to give panels sufficient opportunity to discuss suggested changes to the Handbook at panel meetings if they so wish. All feedback received -

both minor and major will be considered in the process of making changes and additions to the H a n d b o o k . I C V Coordinators will bring more information on the review and how to contribute to panel meetings in the autumn.

Monitoring Chinese detention centres

The pilot lay visitor scheme to promote police accountability and improve human rights at а detention centre in Liaoyuan, a small city with population of one million in North East China, is underway and visits will take place over the next six months.

Twenty lay visitors have been selected from the People's Liaoyuan Congress and the Political Consultative Conference to visit the detention and interview centre

detainees and detention officers to check that treatment is fair and humane.

The pilot has the support of the local Mayor, the Secretary of the Political and Legal Committee of Liaoyuan Chinese Communist Party and Director of the Liaoyuan People's Security Bureau and the Prosecutor Director General.

Recently, Richmond ICV Nicola Macbean, in her capacity as Director of the Rights Practice, along with her colleague Elissa Nessori, delivered a day of training to introduce the UK's Independent Custody Visitor scheme. The training focused on the importance of protecting the rights of detainees and the role of external independent monitors.

presentations Nicola's discussed detainees' basic needs, legal rights and entitlements and emphasised the need for ensuring accountability. Researchers from



the benefits of the introduction of such a scheme. Researchers will monitor the visits to see if police practices change and whether the visits contribute towards improved treatment of detainees. We hope to hear about the results in the coming months.

Russian delegation look to MPA for guidance

The MPA recently hosted a group of delegates from Russia who were visiting the UK to look at oversight arrangements аt detention facilities in both prisons and police stations.

The delegation also made arrangements to visit the Immigration Monitoring Board the secretariat at Ministry of Justice and Holloway Prison. They also visited Northern Ireland to carry out a


similar fact finding mission. The delegation of nine consisted of a member of the Ombudsman of Russian Federation. the Chair of the Independent Council on Human Rights and several journalists from well known Russian newspapers, including the president of Moscow journalists.

Ian Smith, Chief Executive of ICVA (Independent Custody Visiting Association), explained the history, principles and benefits of custody visiting.

Kerry McClelland, ICV Scheme Manager at the MPA, spoke about the of the police role authority, the structure of the London ICV scheme and how issues were raised and resolved, as well as the recruitment process here in London.

His funeral was attended by many members of the local community, including senior borough police officers, some of whom spoke or gave a reading.

Links with CEGs

It is intended that relations between ICV panels and local Community Engagement Groups (CEGs) should be enhanced over the coming year, as there is variation in the amount of liaison across London currently.

As a starting point, all CEGs will receive a copy of the local ICV panel's Annual Report, and potentially updates on ICV issues and work in their area every 3-6 months. We would encourage attendance at CEG meetings from a panel representative, usually (but not always) the Chair or Vice-Chair.

Changes to the MPA

Did you know that the MPA is made up of 23 members, 12 from the London Assembly, 4 magistrates and 7 independents, one of whom is directly appointed by the Home Secretary? No?

Well, from October this year it will all change and the Authority will consist of 12 London Assembly members and 11 independents, including one who should have experience as a magistrate and one who is the Home Secretary's appointee.

Along with the changes to independent membership, the Mayor will be able, for the first time, to Chair the Authority and with Boris Johnson signalling his intent to do so, the beginning of October will definitely be the start of a new era for the MPA.

Diversity Questionnaire

There has been a great response from ICVs to the Diversity Monitoring exercise. To date the scheme manager has received 219 completed forms. This is in addition to those that had already been received during the recruitment process in recent months.

Lead member for the ICV scheme John Roberts said he was "delighted with the response, and it will greatly assist members to get a more accurate picture of the ICV scheme across London".

Southwark one year on

July last year saw Southwark ICVP struggling to carry out weekly visits to its three local stations, with just five active members. As a result visiting stopped for a short period over the summer.

An intensive recruitment campaign began in April 2007, with Coordinator Sarah Walker attending university fairs, volunteer centres and posting out leaflets and posters to public places across the borough.

This all bore fruit eventually and in September the panel began visiting again.

There are now 16 active members on the panel and they have carried out 65% of their visits in the first six months of this year, up from 36% for the same period last year.

Recruitment is still ongoing and it is hoped the panel will continue to improve its visiting performance in the second half of the year.
