Headlines from crime statistics

- Total notifiable offences fell by 6.4%
- BCS comparator crime is down 9.2% against a 5.5% reduction target for 2007/08
- Burglary dwelling has fallen by 2.7%
- A reduction of 13.5% in robbery offences
- Business crime fell but mainly due to changes in recording practices for fraud & forgery
- Motor vehicle crime has fallen by 12.5%
- Gun enabled crime increased and Trident gun crime remains steady compared with the same three months last year
- Seven additional homicides compared with the same period last year
- Rape offences are 24.5% lower than last year
- Violent crime has fallen by 8.1%
- All types of hate crime are down compared with last year
- All types of hate crime have improved SD rates compared with last year





- The gap between white & BME victims is only 1 percentage point.

Overall confidence and satisfaction in policing remains higher than in 2004/05, but not at the
exceptionally high levels seen in 2005/06 probably as a result of the police response to the
July bombings.

- (1) Survey company and some aspects of methodology changed for this survey in 2005/06 and they may be the reason for at least some of the improvement
- The overall level of satisfaction with total service remains steady, currently on average at 78% (down from 79% last year, but not significantly so, and up 10 points on 2004/05).
- The gap between white and BME victims overall satisfaction with the service has closed slightly, with the gap at 6 percentage points, down from 7.
- While there are mixed results in 2006/07 compared with 2005/06, all of the survey results have improved in comparison to 2004/05.
