The Metropolitan Police Authority now wants to know what you think.

Recommendation 61 states that any one who is stopped by a police officer should be given a record of the stop.

What is a 'stop'?

A 'stop' is when a police officer stops you and has a conversation, perhaps asking you to account for your actions, behaviour or your possessions. Once the officer is satisfied with your answers, you are free to go.

What is a 'search'?

A 'search' goes further, for example, by removing clothes or looking into your pockets or bags or in a car or van. The search can be done with or without your co-operation. But the police must have a good reason for searching you and they must write down the details.

The purpose of this questionnaire is to explore your views and preferences about which encounters between the police and the public should be formally recorded.
