Central Operations combined operation	In May 2006, Central Operations planned and executed an operation to disrupt criminals traversing the River Thames, by means of an intelligence-led Automated Number Plate Recognition (ANPR) operation mounted on various Thames bridges to target in particular offenders planning to commit violence. This tactic required the combined support of the Automated Number Plate Recognition (ANPR) teams and Tasking teams from CO15 Traffic OCU and CO20 Territorial Support Group (TSG), as well as borough based resources provided by Territorial Policing. The operation was particularly successful in preventing criminals from crossing the river in order to offend. Air Support Unit	Police were alerted to a suspect device, cylindrical and with nails strapped to it. Upon arrival and assessment by local officers, it was deemed necessary to move the public away from the device. This device was situated within a busy area of Shepherds Bush. The MPS helicopter was requested and deployed to the vicinity to assist local Police in moving the crowds, as they appeared to be ignoring ground units.  A moped failed to stop for Police. The MPS helicopter deployed to the vehicle pursuit and provided commentary to NSY and ground units as to the vehicle and suspects location. CO17 Transport	TOCU South East Task Team officers were on a plain-clothed pushbike patrol in Camberwell when they spotted two youths behaving suspiciously outside a shop. One was suspected of acting as a lookout while the other was inside. When both of the youths left together, the officers followed them to a side street, calling on a police carrier to block off the exit at the other end of the street. The suspects were searched.	•	One suspect had a bag of cannabis and was fined. The other was wearing two pairs of trousers and had a 9 mm bullet in his back pocket and was sentenced to six months imprisonment for possession of a live round of ammunition.  Suspects were found to be on the Trident nominal list.


	Officers from the TOCU's South West route team B were conducting routine patrols in Tooting when they stopped a car after spotting that its driver was not wearing a seat belt. The officers' suspicions were aroused when they noticed the smell of cannabis coming from the car. The vehicle was searched and also the occupants' home address.	• (	A large quantity of drugs including 85 rocks of crack cocaine and cannabis were found in the vehicle.  Officers recovered a large quantity of stolen goods including bankcards and mobile phones from the home address.  One of the four occupants was found to be on the borough's 10 most active criminal list.
	Two suspects, aged 14, had attempted to set fire to a bus in Romford on the 8 July, the day after the bombings. They then succeeded in setting fire to another bus on 20 July, which resulted in its total destruction, endangering the lives of seven people who were on board at the time. Damages amounted to £80,000. BusTag officers analysed CCTV images and identified the school that the two boys attended from their uniforms they were wearing at the time.		Both youths were found guilty of arson with intent to endanger life.
CO19 Specialist Firearms	The following example of operational success highlights the type of operation Specialist Firearms Officers are engaged in on a regular basis. Officers from CO19 working alongside SCD8 (Trident and Trafalgar) officers arrested a 27-year-old male in Forest Gate East London. The operation resulted in two handguns with silencers and more than 100 rounds of ammunition being seized.

### **Examples of Central Operations developed performance measure**

The examples given relate to one particular aspect of Capital City Policing – policing London's transport networks – and show holistic performance measures as delivered by three Central Operations operational command units: Traffic OCU, Traffic Criminal Justice OCU and Transport OCU.

Traffic OCU is responsible for reducing road casualties and making the roads a crime free environment. The first performance measure selected is the number of killed and seriously injured casualties on London's roads, and the Public Service Agreement targets have been adopted.

The second set of Traffic OCU measures further monitor activities aimed at casualty reduction as well activities to reduce crime on the road network. "THINK!" campaign activity is measured through the number of Fixed Penalty Notices issued for offences of speeding, failure to wear a seat belt and not being in proper control of the vehicle (usually driving whilst operating a mobile telephone).


The third set of measures look at judicial outcomes from much of the first two sets of activities and these are owned by the Traffic Criminal Justice OCU. The table below shows the types of activities measured, along with annual volumes.

Research by the TRRL indicates that fatal and serious collisions fall by at least 59% at camera sites


Introduction of Traffic and Transport CJU (pilot project)

Introduction of full centralisation of MPS traffic prosecution at Marlowe House in 3 stages


Centralised processing by TCJ OCU has ended a traffic prosecution "postcode lottery" where police action depended on local priorities. Now where there is evidence of bad driving, either from a collision report or a police report, a driver will always be prosecuted to a consistent standard.

The final set of measures demonstrate performance of Transport OCU whose work is about keeping specified sections of the public transport network (for example, nominated bus routes) safe and secure and congestion free.


#### Passenger perception of safety/security on-bus




#### Passenger perception of safety/security at bus stops/shelters
