

NW Region – Public Complaints

Islington, Harrow, Barnet, Haringey, Ealing, Brent, Hillingdon, Camden Officer Allegations based on officers unit at time of incident



Hillingdon

There were 235 officer allegations against officers in Hillingdon recorded in the year October 2004 to September 2005. Of those allegations, 23% were for incivility, 20% for other assault and 18% failures in duty.

Hillingdon recorded 10 public complaints of racial discrimination.

There have been 229 resolutions of public complaints recorded within the 12 months to September 2005. Of those complaints resolved, 38% were local resolutions, 24% unsubstantiated, 24% withdrawn, 7.4% not recorded, 5.4% dispensation and 0.9% substantiated (2 cases of the 229).

Brent

There were 310 complaints recorded in the 12 months to September 2005 in Brent. Of those allegations, 24% were for failures in duty, 21% for incivility and 20% for other assault.

20 of the allegations were recorded for racial discrimination and 1 for other discriminatory behaviour.

There have been 322 resolutions of public complaints recorded in Brent for the 12 months to September 2005. Of those complaints resolved, 28% were local resolutions, 26% unsubstantiated, 21% withdrawn, 18% dispensation, 5% not recorded and 1.6% substantiated (5 cases of the 322).

Ealing

In the 12 months to September 2005, Ealing has recorded 42 allegations of public complaint per 100 officers (680 officers). There were 285 allegations recorded, with 38% for failures in duty, 15% for incivility and 13% for other assault. Ealing has recorded 10 racial discrimination allegations in the 12 months to September 2005.

There have been 246 resolutions of officer allegations recorded in Ealing. Of these complaints resolved, 47% were local resolutions, 25% withdrawn, 21% unsubstantiated, 2.4% dispensation, 2% not recorded and 2% substantiated (5 cases of the 246)



<u>Hillingdon</u>

Hillingdon has the highest recorded number of allegations for conduct matters per 100 officers (499 officers). For the 12 months to September 2005 there were 45 allegations recorded in Hillingdon. Of those allegations recorded, 20% were for failures in duty, 15.6% was recorded equally for discriminatory behaviour and other assault.

All of the discriminatory behaviour allegations were for racial discrimination.

There were 40 allegations resolved in the 12 months to September 2005 in Hillingdon. Of those allegations resolved, 55% were unsubstantiated, 40% substantiated (16 cases) and 5% not informed.

Barnet

Barnet has recorded 48 officer allegations for conduct matters in the 12 months to September 2005. This equates to 8.7 allegations per 100 officers in Barnet (550 officers). Of those allegations recorded, 42% were for failures in duty, 38% for other allegations and 6.3% for traffic irregularity. There were no allegations recorded for discriminatory behaviour.

There were 37 allegations resolved in the 12 months to September 2005. Of those allegations resolved, 70% were substantiated (26 cases), 24% not substantiated and 5% not informed.

Ealing

Ealing has recorded 35 officer allegations for conduct matters in the 12 months to September 2005. This equates to 5.2 allegations per 100 officers in Ealing (680 officers). Of those allegations recorded, 37% were for failures in duty, 14% for incivility and 11.4% for both other assault and discriminatory behaviour. Ealing recorded discriminatory cases for gender, homophobic and racial behaviour.

There were 34 allegations resolved in the 12 months to September 2005 in Ealing. Of those allegations resolved, 56% were substantiated (19 cases), 41% unsubstantiated and 2.9% not informed.
