- 4.3 The Chair of the Sub-Committee informed members that the complainant had requested that the meeting of the Sub-Committee be delayed, however, the request was declined as members were keen for the complaint to be considered within the 20 day timescale specified in the MPA's procedure.
- 4.1 Having considered the complaint the Assessment Sub-Committee resolved as set out below.
