It is therefore possible for the two ages to appear as if they don't match. Victims: In some cases, the Victim's gender doesn't match the gender specified in the Home Office code. This is probably due to coding errors on the crime record. These are highlighted in the grey boxes. People Proceeded Against: Women cannot be accused of Rape. However, according to the records, some women have been accused of Rape. It is likely that these are for aiding/abetting rape, but this would require further investigation. Again, these are highlighted in the grey boxes.
