2. Name of the policy, strategy or project:

Public Protection (see Project Initiation Document for Met Forward)

3. What is the main purpose or aims of the policy, strategy or project?

To ensure successful delivery of effective and efficient monitoring and scrutiny of MPS activity around all forms Public Protection, with the exception of Counter-terrorism. 'This project will bring safeguarding adults and MAPPA within the MPA scrutiny programme. This scrutiny will take the form of existing oversight mechanisms within the MPA; primarily the committee structure by which the MPA holds the MPS to account publicly on behalf of Londoners.

It should be noted that a number of areas of Public Protection are already well established within the MPA scrutiny function, or are held under different Met Forward projects. These are;

Violence against women Rape Child Protection Hate Crime Counter-terrorism

4. Who will be the beneficiaries of the policy/strategy/project?

MPA – Successful completion of public protection oversight as required by Met Forward. Assurance that the MPS is meeting its responsibilities in relation to public protection.

MPS – Any gaps in service delivery identified, poor performance challenged, new policies and strategies explored and approved, and good practice disseminated.

Londoners – Better delivery of public protection, assurance that police activity is independently overseen on their behalf by the MPA.

5. Has the policy/strategy/project been explained to those it might affect directly or indirectly?

MPA – Yes

MPS – Yes

Londoners – Not directly within the context of including safeguarding adults and MAPPA. However in the process of undertaking research to consider the impact of this project the MPA explored information provided to the MPA directly from Londoners.

Londoners are consulted by the MPA in relation to policing priorities, which inform the annual policing plan. A number of different methods were used, long and shorter questionnaires as well as research and other surveys. One of the priorities identified was anti-social behaviour, this is an area of policing which is considered to have a high impact on older people (British Crime Survey as referenced on help the aged website).

Gun and knife crime, violent crime, and other serious crimes were also frequently highlighted as priorities, perpetrators of which could fall under categories for MAPPA management.

Trust, confidence and accountability were not identified as high priorities but nevertheless placed at a mid-level in terms of priorities and by integrating high priorities into the MPA scrutiny work plan we are ensuring that Londoners can have confidence in the current accountability structure.

It also ensures that the MPA will more consistently assess the completion of EIAs in relation to public protection and can measure the MPS compliance with equality legislation.
